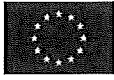

- **The building of collaborative research on a Romanian commentary for Evangelicals in Romania.**

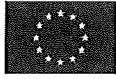
Added value of the mobility (in the context of the modernisation and internationalisation strategies of the institutions involved):

- **First-hand interaction with sources and western NT scholars.**
- **Building and refining the biblical study and exegetic argument.**

Content of the teaching programme:

A Greek exegesis of the New Testament Letter of Ephesians will be taught. Also, two lectures will be delivered on the nature of letters in the ancient literature and communication, in the New Testament world.

Expected outcomes and impact (e.g. on the professional development of



the teaching staff member and on the competences of students at both institutions):

The teaching staff member will become more adept in the Romanian language. Networking with Romanian scholars will be developed.

Students will be exposed to a scholar from Western Europe who is doing research on Paul and his letters.

1 Adaptations of this template:

- In case the mobility combines teaching and training activities, **this template** should be used and adjusted to fit both activity types.
- In the case of mobility between **Programme and Partner Country HEIs**, this agreement must be always signed by the staff member, the Programme Country HEI and the Partner Country HEI (three signatures in total).
- In the case of **invited staff from enterprises to teach in Partner Country HEIs**, this agreement must be signed by the participant, the Programme Country HEI as beneficiary; the Partner Country HEI receiving the staff member and the Programme Country enterprise (four signatures in total). 2 **Seniority:** Junior (approx. < 10 years of experience), Intermediate (approx. > 10 and < 20 years of experience) or Senior (approx. > 20 years of experience).

3 **Nationality:** Country to which the person belongs administratively and that issues the ID card and/or passport.

4 Any Programme or Partner Country enterprise or, more generally, any public or private organisation active in the labour market or in the fields of education, training and youth .

5 **Erasmus Code:** A unique identifier that every higher education institution that has been awarded with the Erasmus Charter for Higher Education receives. It is only applicable to higher education institutions located in Programme Countries.

8 A minimum of 8 teaching hours per week (or any shorter period of stay) has to be respected. If the mobility lasts longer than one week, the minimum number of teaching hours for an incomplete week shall be proportional to the duration of that week. If the teaching activity is combined with a training activity during a single period abroad, the minimum is reduced to 4 teaching hours per week (or any shorter period of stay). There is no minimum number of teaching hours for invited staff from enterprises.

9 Circulating papers with original signatures is not compulsory. Scanned copies of signatures or electronic signatures may be accepted, depending on the national legislation of the country of the sending institution (in the case of mobility with Partner Countries: the national legislation of the Programme Country). Certificates of attendance can be provided electronically or through any other means accessible to the staff member and the sending institution.
